PREFACE

This report examines the monthly inflation rate performance in Namibia as measured by the Consumer Price Index (CPI). The inflation rate measures the change in the CPI for the month under review compared to the previous month (month-on-month changes) as well as to the corresponding month in the previous year (year-on-year changes). The inflation rate is vital for purposes of economic policymaking, especially the conduct of monetary policy and to consumers in general. The Consumer Price Index is published about 15 days after the end of the reference month to which it relates.

In September 2022, the annual inflation rate continued an upward trend increasing by 7.1 percent compared to 3.5 percent recorded in September 2021. On a monthly basis, the inflation rate increased by 0.1 percent compared to 0.3 percent recorded a month earlier. Transport; and Food and non-alcoholic beverages components continued to be the main contributors to the annual inflation rate with a contribution of 2.8 percent and 1.7 percent, respectively.

The Zonal inflation rates for the month of September 2022 revealed that, Zone 2 (Khomas) recorded the highest annual inflation rate of 7.8 percent followed by Zone 3 (Hardap, Omaheke, //Karas, and Erongo) at 6.9 percent and Zone 1 (Kavango East, Kavango West, Kunene, Ohangwena, Omusati, Oshana, Oshikoto, Otjozondjupa, and Zambezi) annual inflation rate stood at 6.6 percent. On a monthly basis, Zone 1 and Zone 2 recorded inflation rate of 0.1 percent each, while Zone 3 recorded the monthly inflation rate of 0.2 percent.

Analysis of the average retail prices of a selected products for the month of September 2022 revealed that consumers in Zone 3 paid the highest price for Chicken, frozen assorted pieces (1.5kg) at N\$76.99 followed by Zone 2 at N\$75.24, while consumers in Zone 1 paid the lowest price of N\$69.24. For Honey (500g), consumers in Zone 3 paid the lowest price at N\$76.43, while the highest price was paid by consumers residing in Zone 2 at N\$87.88.

I would like to extend my gratitude and appreciation to all stakeholders who assisted in the production of this bulletin. 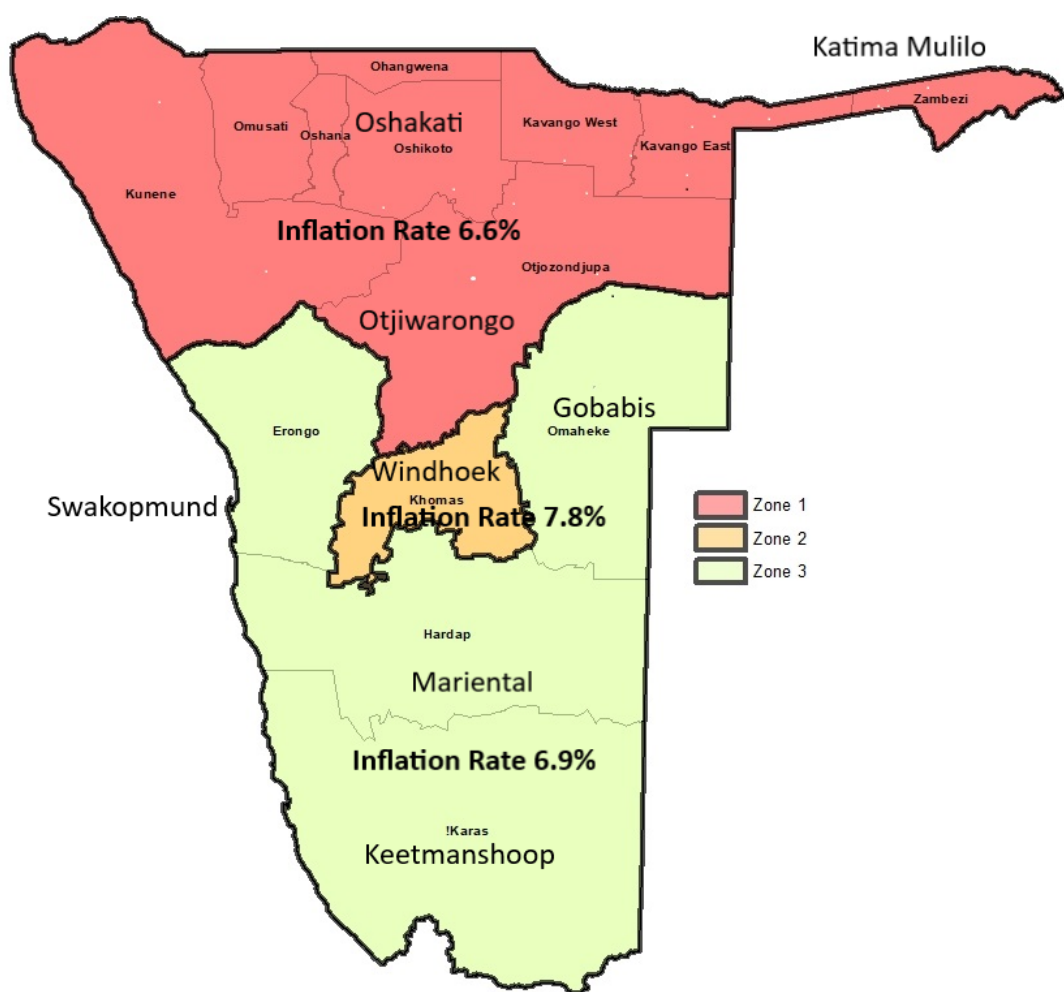

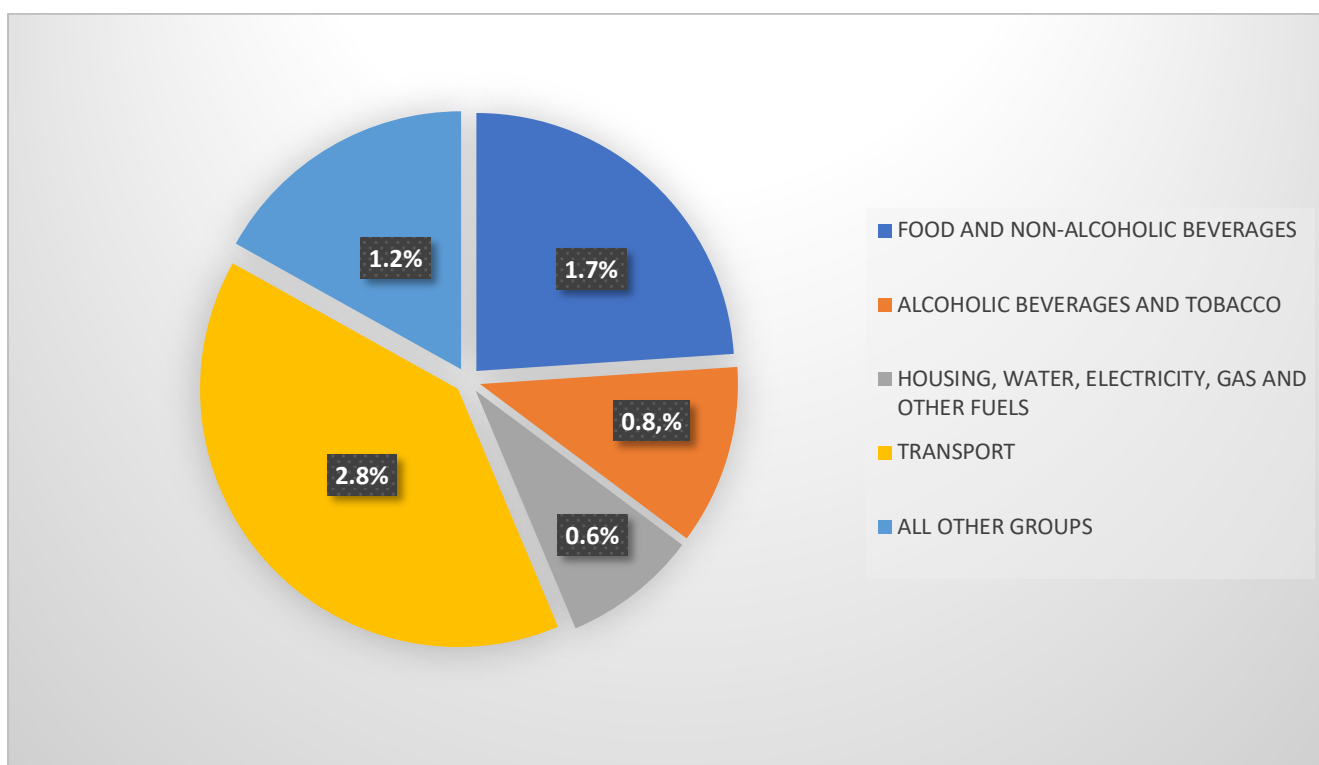

Overall inflation rate

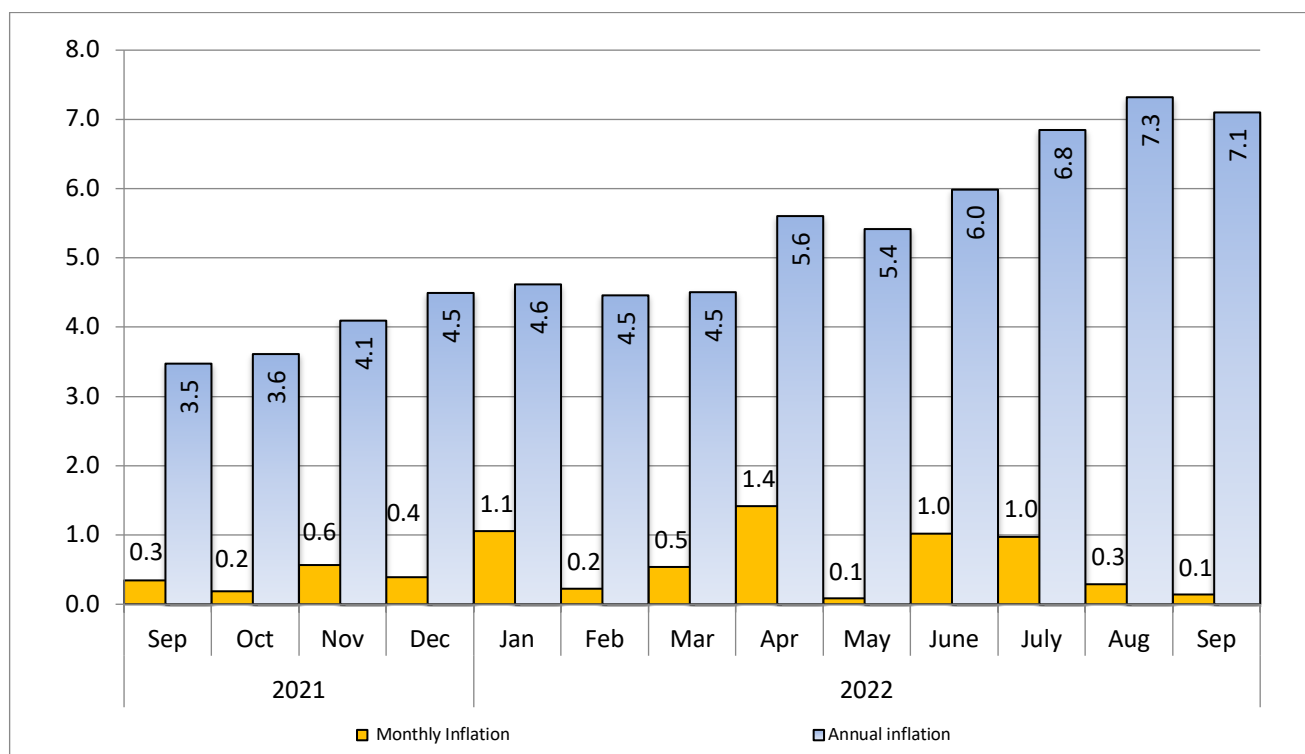
The annual inflation rate for September 2022 stood at 7.1 percent, up from 3.5 percent recorded same period last year. The main contributors to the annual inflation rate for September 2022 were Transport (2.8 percentage points); Food and non-alcoholic beverages (1.7 percentage points); Alcoholic beverages and tobacco (0.8 percentage points); Housing, water, electricity, gas, and other fuels (0.6 percent points) and Furnishing household equipment and routine maintenance of the house contributed (0.5 percentage points).

On a monthly basis, inflation rate increased by 0.1 percent in September 2022 compared to an increase of 0.3 percent obtained during the past month. The slowdown in the monthly inflation rate was reflected mainly in Transport (from 0.2% to -1.6%); Housing, water, electricity, gas and other fuels (from 0.3% to 0.1%); Recreation and culture (from 0.7% to 0.3%) and Food and non-alcoholic beverage (from 0.8% to 0.6%).

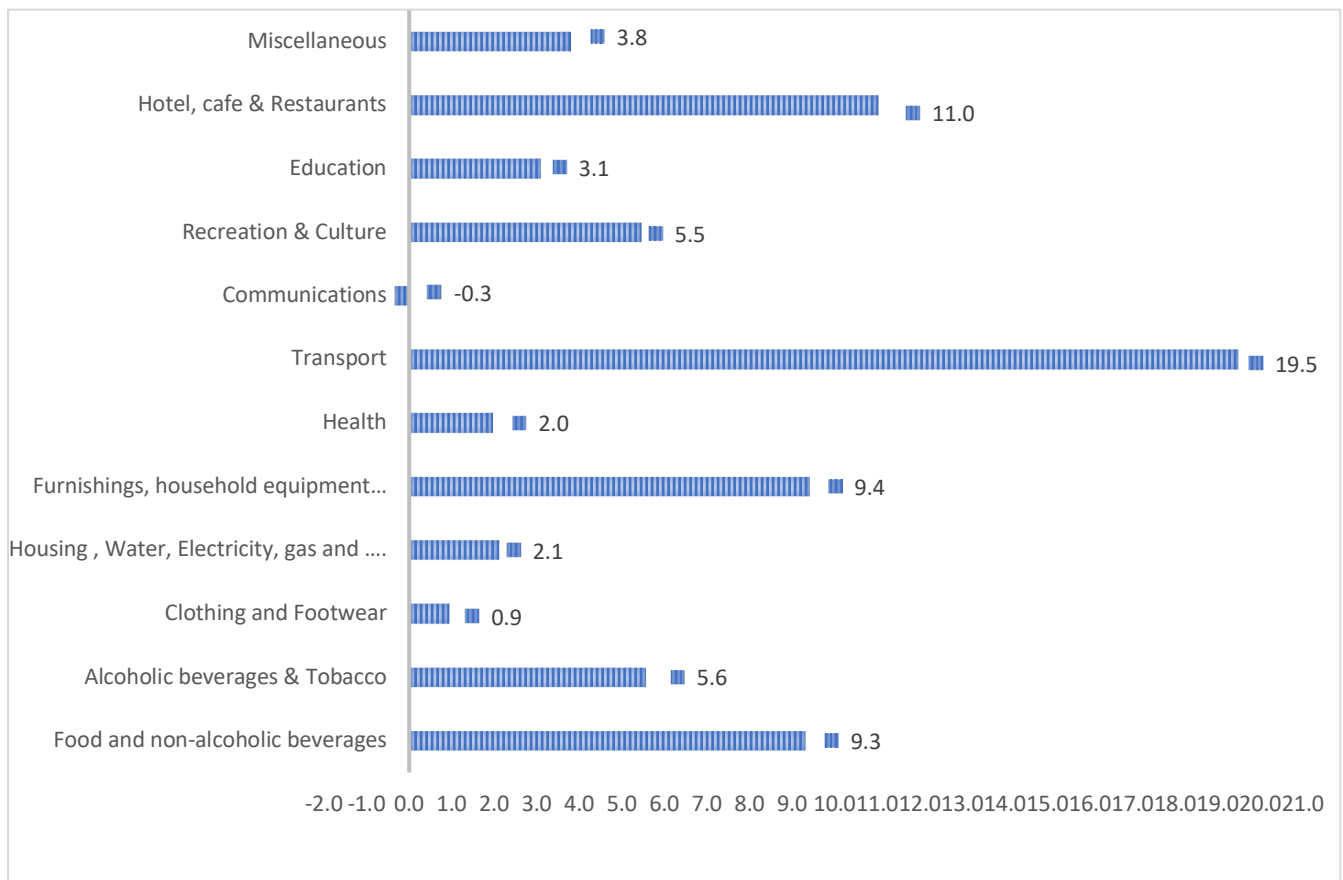
Chart 2: Monthly and annual percentage change (September 2021-September 2022)



Annual inflation rate by main categories

The highest changes in the annual inflation rate were mainly witnessed in the categories of Transport (19.5%); Hotels, cafes, and restaurants (11.0%); Furnishings, household equipment and routine maintenance of the house (9.4%); Food and non-alcoholic beverages (9.3%); Alcoholic beverages and tobacco (5.6%) and Recreation and culture (5.5%).

Chart 3: Annual percentage change by groups for September 2022

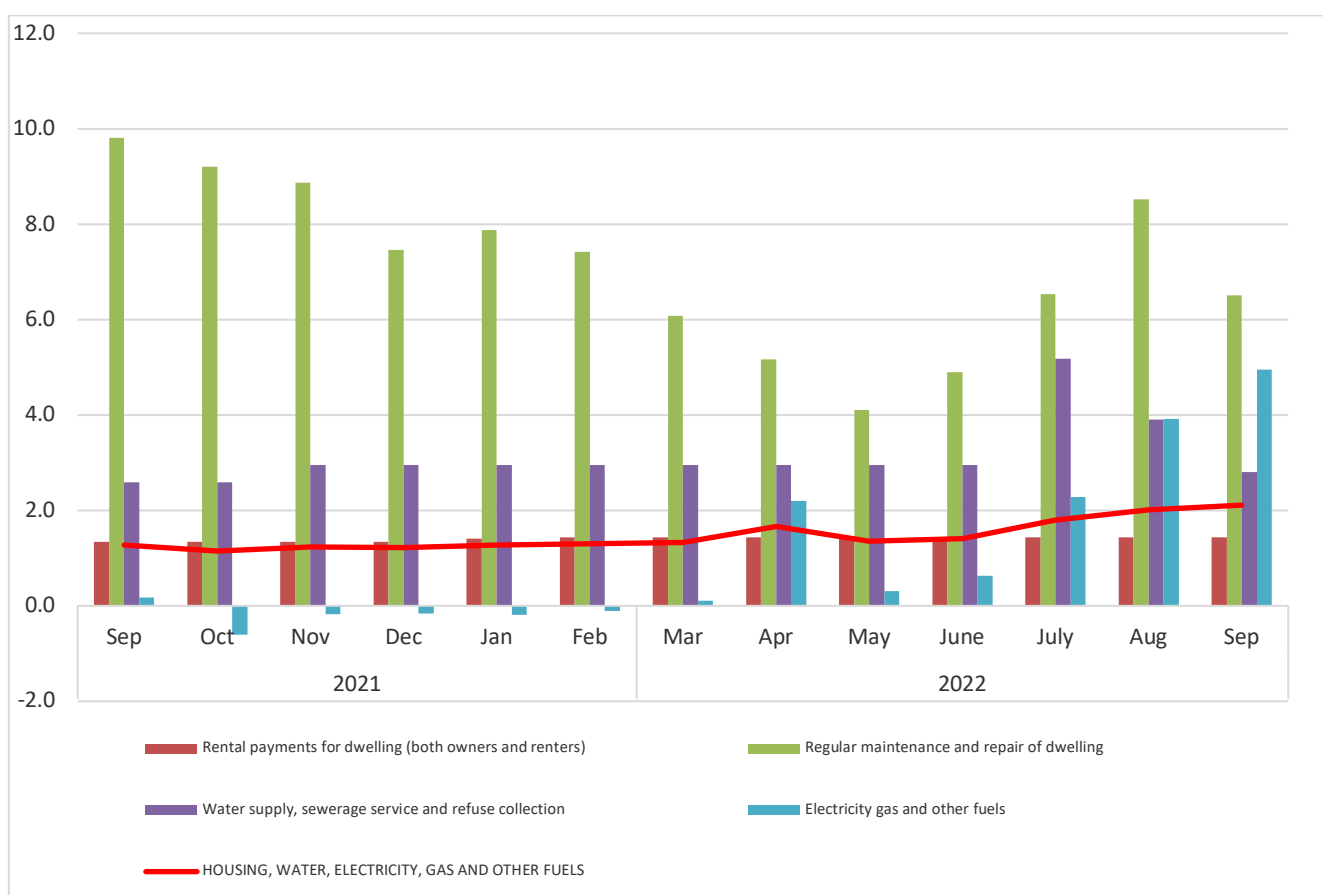


Selected main categories' annual inflation rates

Housing, water, electricity, gas, and other fuels

The annual inflation rate for Housing, water, electricity, gas, and other fuels component which accounts for 28.4 percent of the consumer basket, increased by 2.1 percent during September 2022 compared to 1.3 percent registered during the same period of the preceding year.

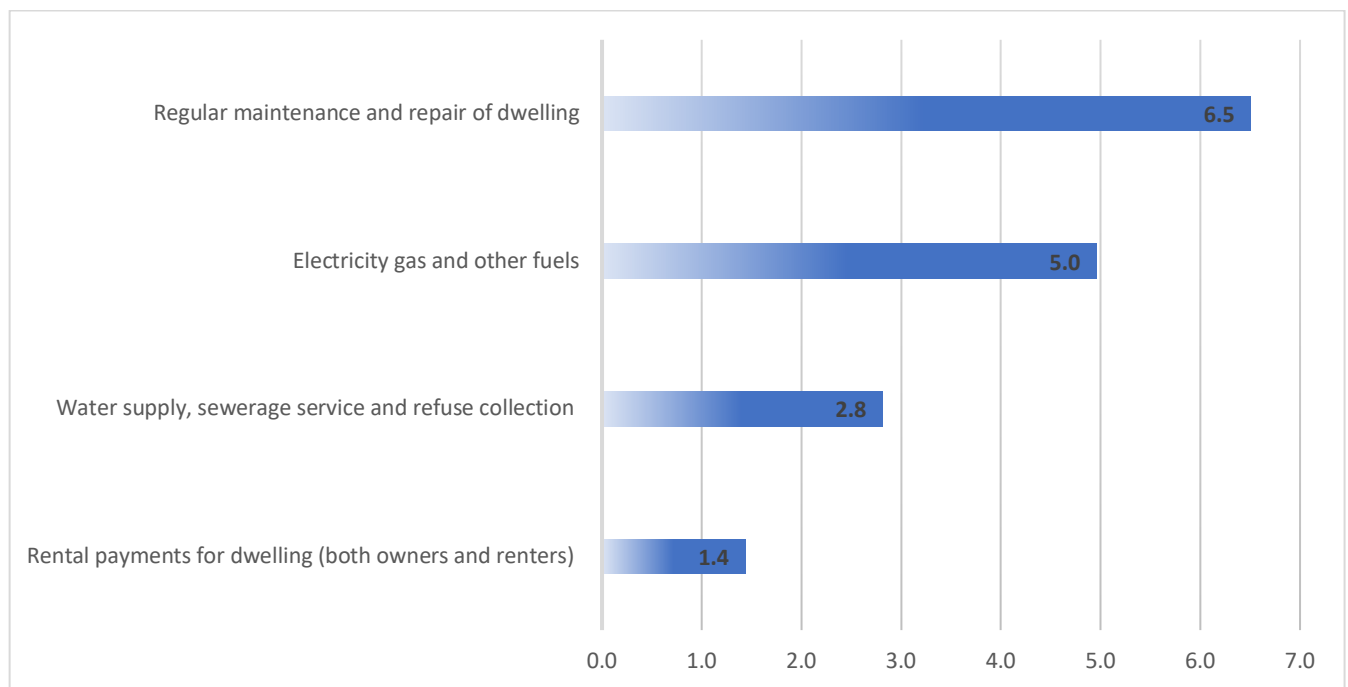
Chart 4: Annual inflation rate for Housing, water, electricity, gas, and other fuels (September 2021-September 2022)



The highest percentage changes in this category during September 2022 were mainly observed in the subcategories of Regular maintenance and repair of dwelling (6.5%); Electricity gas and other fuels (5.0%) and Water supply, sewerage services and refuse collection (2.8%).

On a monthly basis, this category recorded an inflation rate of 0.1 percent in September 2022 compared to 0.3 percent recorded during the previous month.

Chart 5: Annual inflation rate for Housing, water, electricity, gas and other fuels for September 2022

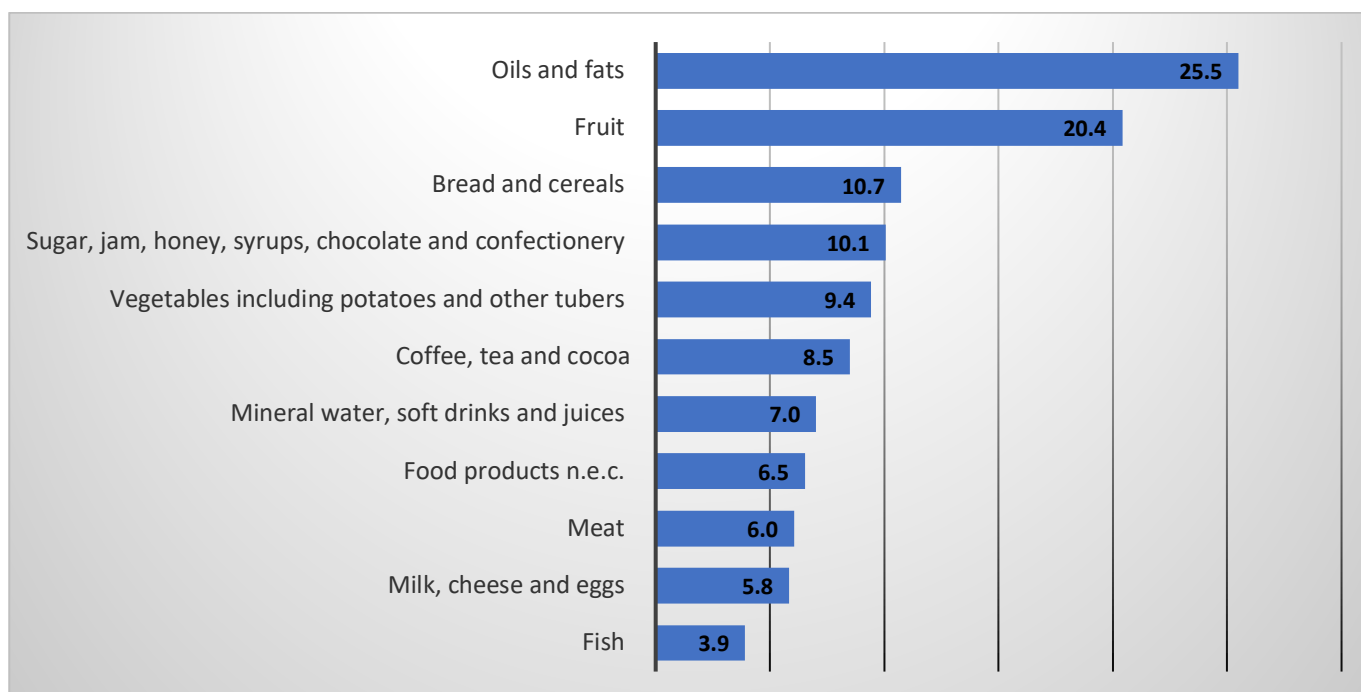


Food and non-alcoholic beverages

Food and non-alcoholic beverages which accounts for 16.5 percent of the NCPI basket recorded an inflation rate of 9.3 percent during the month of September 2022 compared to 5.0 percent registered during same period of last year.

On a monthly basis, price levels for this category increased by 0.6 percent during the period under review compared to 0.8 percent recorded a month earlier.

Food sub-category accounts for 14.8 percent of the consumer basket in the CPI. Within the food sub-category, bread and cereals accounts for the highest weight of food items that consumers purchase, having a weight of 4.8 percent followed by Meat (3.5%); Sugar, jam, honey, syrups, chocolate, and confectionery (1.4%); Vegetables; and milk, cheese, and eggs (1.2%) each.

The inflation rate for the Food sub-category increased by 9.5 percent during the period under review compared to 5.1 percent registered during the same period of the preceding year. The increase was mainly reflected in the prices of Oils and fats (25.5%), Fruits (20.4%), Bread and cereals (10.7%) and Sugar, jam, honey, syrups, chocolate, and confectionery (10.1%).

Oils and fats prices augmented by 25.5 percent in September 2022 compared to 17.7 percent registered during the same period a year earlier. The increase was reflected mainly in the price levels of Cooking oil that escalated (from 26.7% to 36.1%); Margarine & margarine spreads (from 9.5% to 18.2%) and Butter (from 1.3% to 1.5%).

The price levels of **Fruits** increased by 20.4 percent in September 2022 compared to 10.2 percent recorded in September 2021. The increase in the annual inflation rate for this subcategory was mainly observed in the price levels of Avocados (from 32.8% to 77.7%); Citrus fruits (from -7.8% to 22.7%); Dried fruits (from -4.1% to 11.9%) and Peanuts and mixed nuts (from -1.6% to 6.3%).

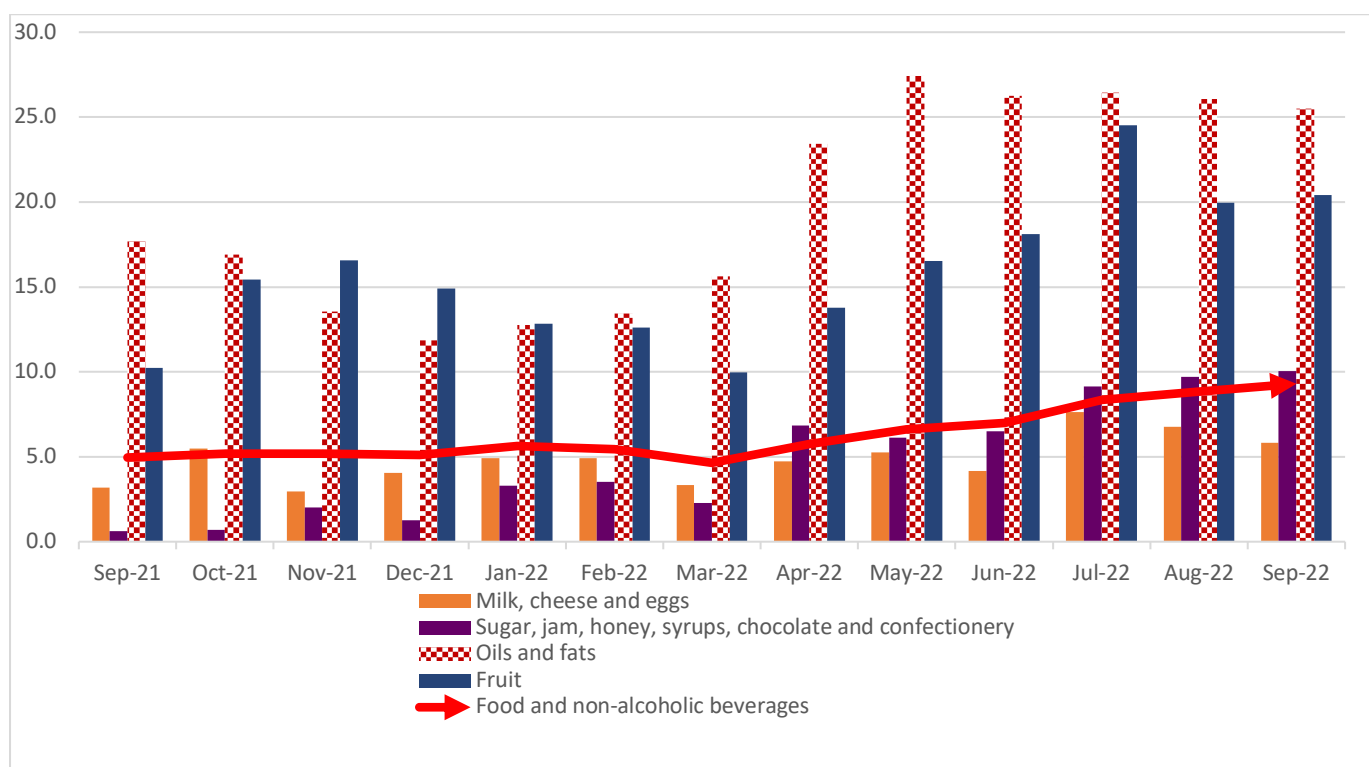
Bread and cereals prices increased by 10.7 percent during September 2022 compared to 1.7 percent recorded same period of the preceding year. The increase in the annual inflation rate for this subcategory resulted mainly from increases in the price levels of Bread, cake flour (from -0.3% to 21.2%); Maize, meal/grain (from -3.5% to 14.8%); Mealie rice/malt (from -1.7% to 9.0%) and Biscuits, rusks (from 0.5% to 10.2%).

The price levels of **Sugar, jam, honey, syrups, chocolate, and confectionary** increased by 10.1 percent during the period under review compared to 0.6 percent registered during the same period last year. The increase was mainly observed in the price levels of Chocolate (from -2.7% to 16.6%); Sweets (from -1.9% to 8.0%); Sugar (from 0.8% to 10.2%) and Ice cream (from 3.3% to 7.7%).

Prices for **Milk, cheese and eggs** increased by 5.8 percent during September 2022 from 3.2 percent registered in September 2021. The increase was mainly observed in the price levels of Fresh cream (from -3.5% to 19.7%); Baby milk powdered (from 4.5% to 12.5%); Fresh milk, long life milk (from -0.5% to 6.4%) and Preserved milk (from 0.6% to 6.8%).

Vegetables including potatoes and other tubers prices increased by 9.4 percent in September 2022, compared to 0.9 percent recorded in September 2021. The increase in the annual inflation rate for this category emanated from increases witnessed in the price levels of Green pepper/Paprika (from -11.8% to 52.9%); Cucumber (from -15.3% to 16.8%); Tomatoes (from -1.9% to 21.2%); and Onion (from -10.2 to 10.6%).

Chart 7: Annual inflation rates for Food and non-alcoholic beverages and selected food sub-categories (September 2021 – September 2022)

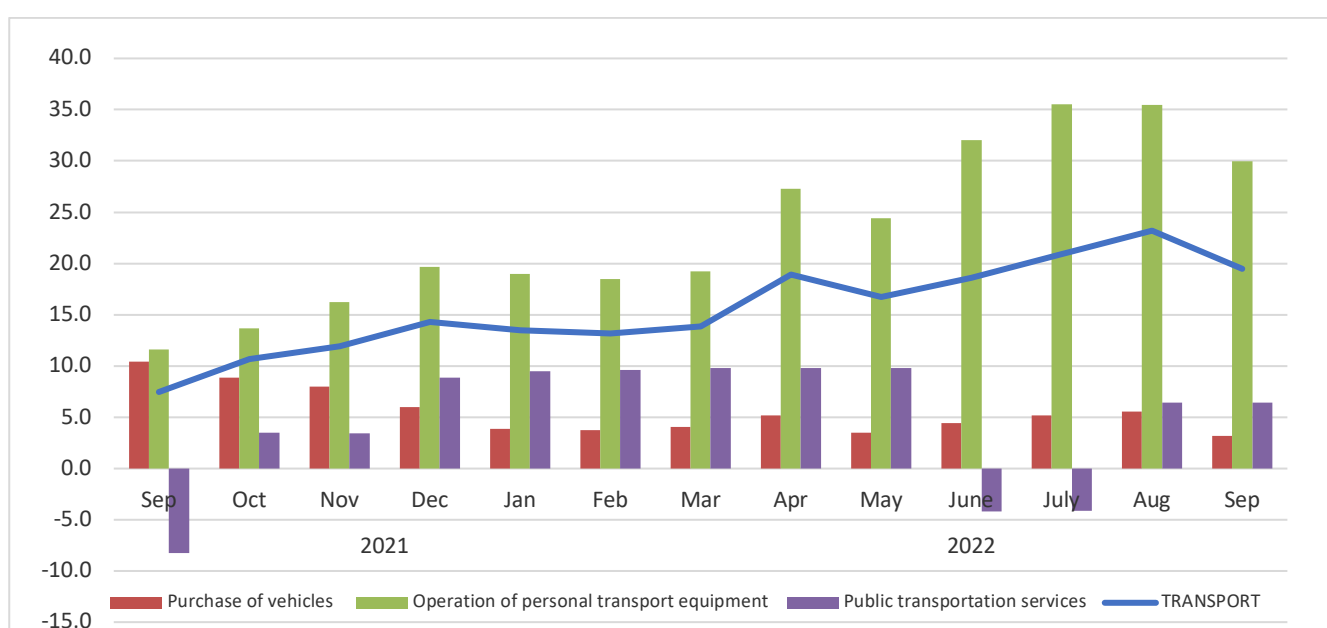


Transport

The annual inflation rate for the Transport category which accounts for 14.3 percent of the consumer basket continues to be the main driver of the overall inflation, increasing by 19.5 percent in September 2022 compared to 7.5 percent registered during the same period of the preceding year. The increase in the Transport component was mainly reflected in the price levels of Operation of personal transport equipment which increased by 30.0 percent.

On monthly basis, Transport recorded a deflation of 1.6 percent in September 2022 mainly on account of declines in fuel prices during the period of review compared to 0.2 percent increase recorded in August 2022.

Chart 8: Annual inflation rate for Transport (September 2021 - September 2022)



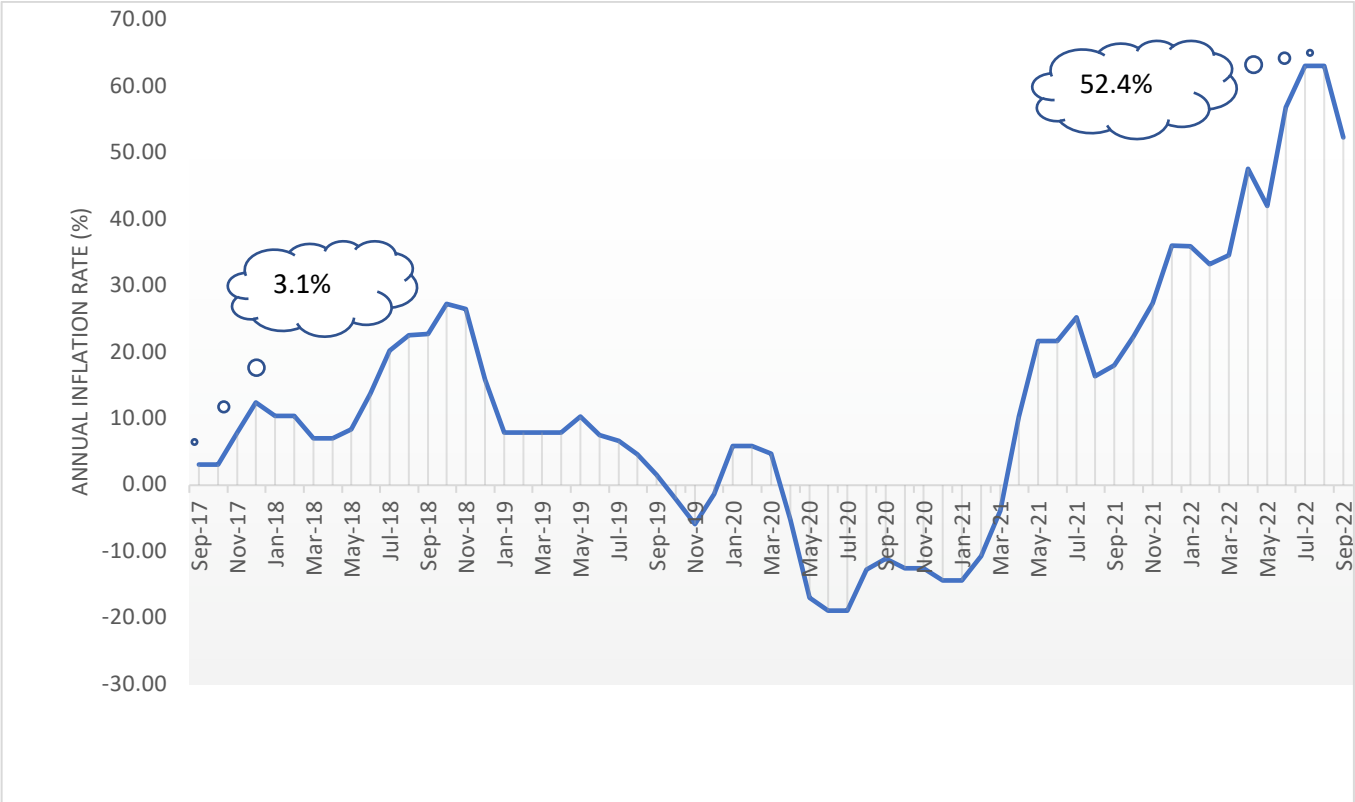
Operation of personal transport equipment increased by 30.0 percent in September 2022, compared to 11.6 percent recorded in September 2021. The increase resulted mainly from increases witnessed in the price levels of Petrol/Diesel which recorded a hyperinflation rate of 52.4 percent in September 2022 compared to 18.0 percent registered during the same period last year.

Prices for Public transportation services recorded an increase of 6.4 percent compared to a deflation of 8.3 percent registered during the same period of 2021. The increase emanated from increases registered in the price levels of Bus transportation which increased (from -12.2% to 8.8%) and Taxi transportation (from -8.7% to 6.3%).

Purchase of vehicles, prices for this subcategory slowed by 3.2 percent in September 2022 compared to 10.4 percent recorded during September 2021. The slow increase was reflected in all the subcategories (Motor cars; Motorcycles; and Bicycles).

During September 2022, Petrol and diesel registered a hyperinflation rate of 52.4 percent when compared to an annual inflation rate of 3.1 percent recorded in September 2017.

Chart 9: Annual inflation rate for Petrol / Diesel (September 2017 - September 2022)

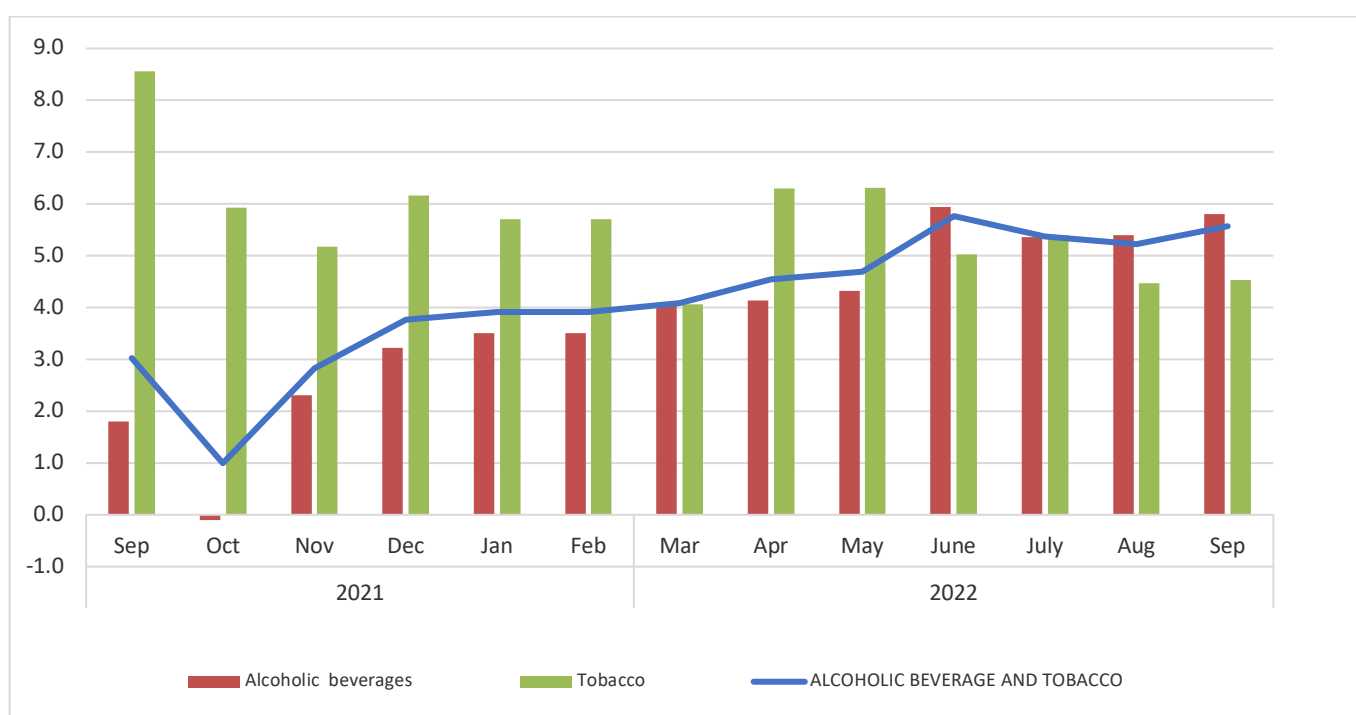


Alcoholic beverages and tobacco

During September 2022, the annual inflation rate for the Alcoholic beverages and tobacco category which accounts for 12.6 percent of the consumer basket rose by 5.6 percent compared to 3.0 percent registered during September of the previous year. The increase in the movement of the inflation rate of this group resulted mainly from an increase registered in the price level of Alcoholic beverages subcategory which increased by 5.8 percent.

On a monthly basis, inflation rate increased by 0.8 percent, when compared to a deflation of 0.3 percent recorded in August 2022.

Prices for Tobacco recorded a slow growth of 4.5 percent in September 2022 compared to 8.6 percent recorded in September 2021. The slowdown registered in the inflation rate was reflected in both subcategories of cigarettes and pipe tobacco.

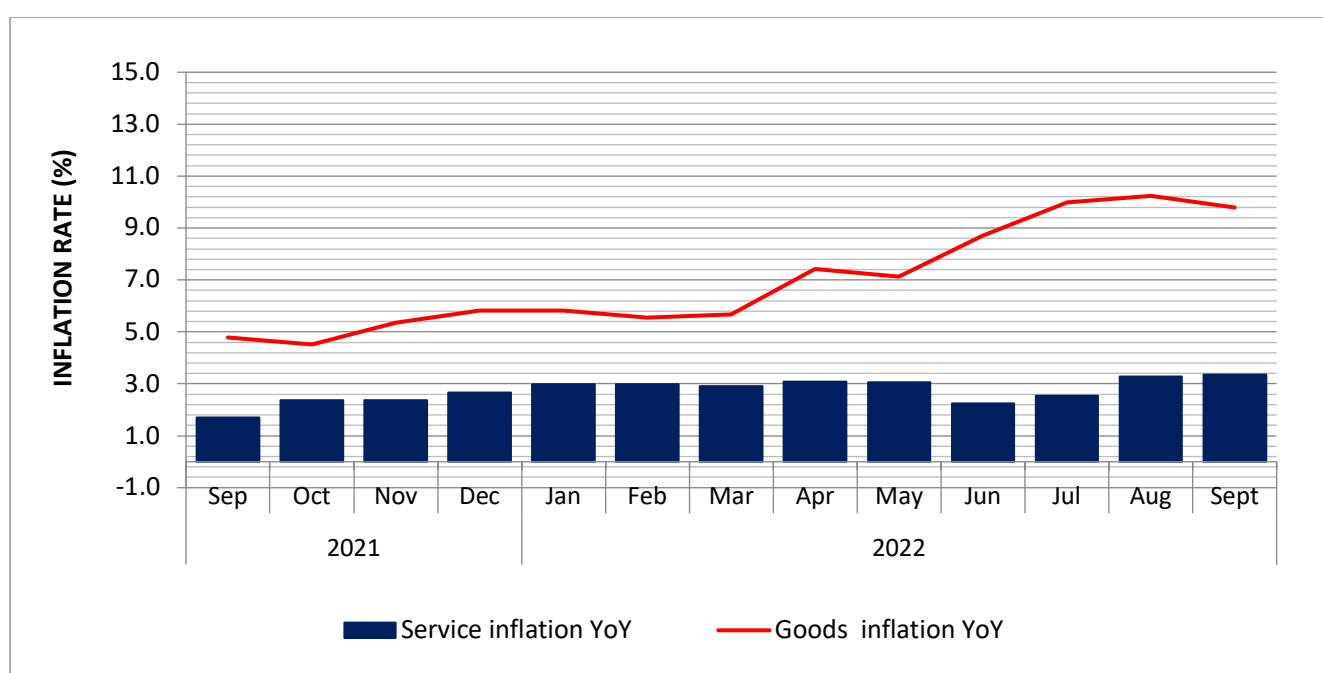
Prices for Alcoholic beverages rose by 5.8 percent in September 2022, compared to 1.8 percent recorded in September 2021. The increase in the price levels of this subcomponent resulted mainly from subcategory of White spirits that increased by 22.0 percent compared to 9.3 percent in September 2021.

Goods and Services inflation rates

In September 2022, the annual inflation rate for Goods increased by 9.8 percent compared to 4.8 percent registered during the same period last year. The annual inflation rate for Services rose by 3.3 percent in September 2022 compared to 1.7 percent recorded in September 2021.

The monthly inflation rate for Goods rose by 0.1 percent in September 2022 compared to 0.4 percent in the previous month. While monthly inflation for Services rose by 0.1 percent in September 2022 compared to 0.2 percent, registered during the previous month.

Inflation rates by Zones

The NCPI is designed to cover the entire economic territory of the country and includes national, urban and rural households of all income groups as derived from the Namibia Household Income and Expenditure Survey (NHIES). For the compilation of the National CPI, all administrative regions of the country were grouped into three Zones, with each zone considered as one geographic area as follows: **Zone 1** (Kavango East, Kavango West, Kunene, Ohangwena, Omusati, Oshana, Oshikoto, Otjozondjupa, and Zambezi); **Zone 2** (Komas) and **Zone 3** (//Kharas, Erongo, Hardap and Omaheke).

Zone 1 - The annual inflation rate increased by 6.6 percent in September 2022 compared to 3.1 percent recorded in September 2021. The increase in the annual inflation rate was mainly reflected in the increases observed in the price levels of Transport (from 9.5% to 17.9%); Food and non-alcoholic beverages (from 4.0% to 9.9%); Hotels, cafes, and restaurants (from 1.5% to 7.1%) and Clothing and footwear (from -3.6% to 2.4%).

On a monthly basis, the inflation rate for September 2022 stood at 0.1 percent compared to 0.4 percent recorded a month earlier.

Zone 2 - The annual inflation rate for September 2022 increased by 7.8 percent compared to 3.1 percent recorded during the same period of 2021. The increase was mainly reflected in the increase witnessed in the price levels of Transport (from 6.3% to 19.8%); Furnishing, household equipment and routine maintenance of the house (from 4.5% to 18.4%); Hotels, cafés, and restaurants (from -1.2% to 14.8%); and Recreation and culture (from 2.9% to 8.7%).

On a monthly basis, the inflation rate remains unchanged at 0.1 percent compared to last month.

Zone 3 - The annual inflation rate increased by 6.9 percent in September 2022 from 4.6 percent recorded in September 2021. The increase in the annual inflation rate emanated mainly from increases recorded in the price levels of Transport (from 5.9% to 21.8%); Alcoholic beverages and tobacco (from 5.2% to 7.6%) and Clothing and footwear (from -2.2% to 0.1%).

On a monthly basis, the inflation rate for September 2022 registered a 0.2 percent compared to 0.4 percent recorded last month

Zonal average prices on selected products

More than 9000 prices of goods and services are collected monthly from more than 900 retail outlets in 8 localities. Analysis of the average retail prices of selected products for the month of September 2022 revealed that consumers in Zone 3 paid the highest price for Chicken, frozen assorted pieces (1.5kg) at N\$76.99 followed by Zone 2 at N\$75.24, while consumers in Zone 1 paid the lowest price of N\$69.24. For Honey (500g), consumers in Zone 3 paid the lowest price at N\$76.43, while the highest price was paid by consumers residing in Zone 2 at N\$87.88.

BOX 3: NCPI basket weights

Inflation is calculated based on a basket of goods and services, containing a representative sample of the goods and or services commonly consumed in a country, and weighted in accordance with the relative percentage of expenditure allotted to each of the said goods at household level. The price of these goods and services are then tracked over time, to illustrate the change in the cost of living over time. As spending patterns change, new products and services are added to the basket, and the basket is reweighted to better capture the current spending patterns of the consumer at the current point in time.

As such, the inflation basket is generally reconstituted every five years. In Namibia, the basket was last rebased in 2013, using household expenditure data collected in the 2009/10 Household Income and Expenditure Survey. The basket now contains over 350 items, grouped into 12 categories and 55 sub-categories, for which prices are collected monthly from more than 900 retail outlets.

Namibian inflation is largely determined by three categories of the overall NCPI basket, namely: (i) *Housing, water, electricity, gas, and other fuels*, (ii) *Food and non-alcoholic beverages* and (iii) *Transport*, which cumulatively make up just under 60 percent of the total inflation basket. Additionally, following the rebasing of the NCPI basket in 2013, “*Alcoholic beverages and tobacco*” make up additional 12.6 percent of the basket, meaning that the four largest categories represent well over 70 percent of the total basket. As such, a large increase in inflation in these categories has a greater impact on the overall inflation than increases in the lower weighted categories. Thus, it is rare to see major increases in overall inflation attributed to the lower weighted categories, despite the fact that these categories may have seen relatively high inflation in their own right.

Annex D: Background of the Zonal Consumer Price Index

The NCPI is designed to cover the entire economic territory of the country and includes national, urban and rural households of all income groups as derived from the Namibia Household Income and Expenditure Survey (NHIES). For the compilation of the National CPI, all administrative regions of the country were grouped into three Zones, with each zone considered as one geographic area as follows.

Zone 1 covers the expenditure patterns of the regions in the northern part of the country namely Kavango East, Kavango West, Kunene, Ohangwena, Omusati, Oshana, Oshikoto, Otjozondjupa and Zambezi. Prices are collected from the following towns: Katima Mulilo (76 retail outlets covering mainly the Central Business District); Oshakati (107 retail outlets covering mainly Game Shopping Center, Yetu Shopping Center, Oshana Mall, Marula Mall and Ongwediva); and Otjiwarongo (114 retail outlets covering mainly the Central Business District, Orwetoveni, and the Industrial Area).

Zone 2 covers the expenditure patterns of Khomas region, and the price collection covers Windhoek (218 retail outlets covering mainly Khomasdal, Katutura, Northern Industrial Area, Southern Industrial Area, Pioneers Park, Hochland Park, Prosperita, Klein Windhoek, Eros and Kleine Kuppe).

Zone 3 covers the expenditure patterns of //Karas, Erongo, Hardap, and Omaheke regions with prices being collected from Keetmanshoop (86 retail outlets covering mainly Central Business District, West Dene and Tseiblagte); Swakopmund (108 retail outlets covering Central Business District, Mondesa, Tamariskia, Industrial Area); Mariental (61 retail outlets covering mainly Central Business District and Ombili); as well as Gobabis (59 retail outlets mainly covering the Central Business District), respectively.

The localities identified for price collection were selected based on a mixed criterion of:

- i. the relative importance of the locality as determined by its relative share exceeding 30 percent of the total household expenditure at national level.
- ii. geographic distribution of economic activities; and
- iii. Regional capitals
