## **WORLD BANK REAFFIRMS SUPPORT FOR NAMIBIA AND SOUTH AFRICA**

A in statement issued by the World Bank's office in Pretoria, it was stated that a delegation of the World Bank Group's (WBG) Board of Executive Directors (EDs) noted South Africa's and Namibia's progress in achieving their development goals and re-affirmed World Bank Group's commitment to providing support. The 11 EDs and Alternate EDs were hosted by the World Bank and International Finance Corporation (IFC) country offices during their recent visit on July 7-13.

The visit provided a platform to assess progress with projects and engage on the evolution of the World Bank Group's relationship with the countries, from a knowledge-focused to a broader knowledge and financing partnership. EDs met government and business leaders, local stakeholders, and project beneficiaries, and experienced first-hand how the countries manage development priorities and challenges. South Africa and Namibia have common challenges, including poverty, unemployment, and inequality. Throughout the visit, the delegation discussed the ongoing and future support from the World Bank Group to boost inclusive economic growth and job creation.

In Namibia, the World Bank Group is preparing a new Country Partnership Framework (CPF) with the government

that will strategically guide its support as the engagement continues to grow. The World Bank recently approved a \$138.5 million renewable energy and transmission loan to NamPower, after 15 years without borrowing.

Key highlights of the visit included: In Namibia, the delegation met with Minister of Finance and Public Enterprises, Mr Ipumbu Shiimi and key stakeholders, including development partners and the private sector.

The delegation visited informal settlements near Windhoek to gain insights on housing related issues, a sector where IFC is investing and which the government has identified as a priority for World Bank Group engagement.

Matteo Bugamelli, the World Bank's Executive Director who represents the constituency of countries including Albania, Greece, Italy, Malta, Portugal, San Marino, and Timor-Leste, expressed optimism about the countries' progress. He emphasized the World Bank Group's commitment to helping South Africa and Namibia address unemployment and inequality challenges. He particularly welcomed the increased financing to support the implementation of much needed reforms.

# WINDHOEK APPROVES 928 BUILDING PLANS WORTH N\$921.9 MILLION IN FIRST-HALF

The City of Windhoek approved 928 building plans during the first half of the year with a total value of N\$921.9 million, marking a 1.4% increase in number and a 30.0% increase in value compared to the same period in 2023.

IJG Securities reports that on a twelve-month cumulative basis, there has been a 16.3% decrease in the number of approvals and a marginal 0.1% decrease in value compared to the equivalent period from a year ago. Additionally, 98 building plans, valued at N\$50.5 million, were completed in the month. In June, the city approved a total of 149 building plans, a decrease of 20.7% from the 188 approvals in May.

The total value of June's approvals amounted to N\$109.0 million, which is 42.3% lower than May's approvals. Meanwhile, Windhoek's twelve-month cumulative number and value of residential approvals have been hovering above 330 units and N\$630.0 million for the past few months, with 334 units valued at N\$633.6 million approved by the end of June.

IJG Securities reveals that this is however 40.7% y/y lower in number terms, but 1.1% more in value terms when compared to the corresponding 12-month period a year ago.

# REPO RATE MAINTAINED AT 7.75 PERCENT

On the 17 th and 18 th of June 2024, the Monetary Policy Committee (MPC) of the Bank of Namibia held its third bi-monthly meeting for 2024 to decide on the appropriate monetary policy stance to be implemented over the next two months.

To continue safeguarding the peg between the Namibia Dollar and the South African Rand while supporting the domestic economy, the MPC decided to hold the Repo rate steady at its current level of 7.75 percent.

This decision was made following a comprehensive review of domestic, regional and global economic developments.

Domestic economic activity increased during the first four months of 2024. Inflation slowed year-to-date but edged higher since the previous MPC meeting, while the growth in Private Sector Credit Extension (PSCE) remained subdued. The merchandise trade deficit widened, while the stock of international reserves remained sufficient to support the currency peg and meet the country's international financial obligations.

Global output maintained positive growth in the first quarter of 2024, and it is projected to remain resilient throughout the year. Some inflationary pressures persisted in both the advanced economies and the emerging market and developing economies.

By creating a supportive ecosystem for youth-led enterprises, the Council envisions contributing to poverty alleviation and fostering economic growth in Namibia.

MSMEs will be targeted in the ideation phase with strong business cases and existing businesses seeking support to enhance their growth trajectories. Youth entrepreneurs must enrol in and complete the NextGen Incubation Programme to qualify for financing.

# CIVIL SERVANTS RECEIVE 28 GOREANGAB HOUSES

The Ministry of Urban and Rural Development handed over 28 new houses in Windhoek's Goreangab Extension 4 to public servants as part of the Informal Settlement Upgrading Pilot Project (ISUPP) on Friday.

The ministry's executive director Nghidinua Daniel said, the project targets low-income earners, and these houses were particularly meant for soldiers, police officers, nurses and teachers.

He confirmed, "The 28 houses are a combination of two-bedroom freestanding and one-and-two-bedroom flats that would cater for various income levels of our beneficiaries".

Minister Erastus Uutoni said: "We have entrusted the construction part to the City of Windhoek and the National Housing Enterprise to continue the excellent work they have been doing for the past three years".

# **GLOBAL HYDROGEN SUMMIT SET FOR SEPTEMBER**

The Global African Hydrogen Summit will focus on the role Africa expects to play in the global hydrogen economy.

The summit will take place in Windhoek from 3 to 5 September, under the theme 'From Ambition to Action: Fuelling Africa's Green Industrial Revolution'.

A recent report co-authored by McKinsey and Company and the Hydrogen Council shows how Africa enjoys world-class renewable resources, with capacity factors up to 69% for wind power and 25% for solar power.

The inaugural event forms part of Namibia's COP28 programme and will be hosted by the Namibia Investment Promotion and Development Board, the Environmental Investment Fund of Namibia, DMG events and Vasco Da Gama Energy.

The continent also has excellent geothermal and hydro resources, coupled with abundant land area.

Consequently, the continent is strongly positioned to become a renewable hydrogen and derivatives producer and exporter.

The summit's head of marketing Roshan Jan-Mahomed says Africa holds the key to decarbonising the global energy system and can become a leading player hydrogen produced from renewables.

Several African countries, including Angola, Djibouti, Egypt, Ethiopia, Kenya, Mauritania, Morocco, Nigeria, Namibia and South Africa, are actively pursuing clean hydrogen production goals.

There are many challenges to overcome to establish a sustainable and economically viable hydrogen economy. The most fundamental and urgent obstacles to overcome as a priority include financing and investment,

# **NHE HANDS OVER 119 HOUSES AT SWAKOPMUND**


The minister of urban and rural development, Erastus Uutoni, through the National Housing Enterprise (NHE) handed over 119 houses at Swakopmund to new owners on Monday.

The houses are part of 505 housing units that have been standing uncompleted in the town's Matutura Extension 9 area for years due to a legal dispute between the main building contractor and subcontractors.

Uutoni said the completion of the houses is due to the hard work and teamwork of the new appointed contractor, New Era Investments, and the Ministry of Urban

and Rural Development. "The 119 houses whose handing-over we are witnessing today are the last batch of the 319 houses that were handed over to New Era Investments for completion", Uutoni said.

Uutoni said the cabinet last year in November approved a revised national housing policy with a five-year implementation action plan. The policy gives special attention to the improvement of conditions in informal settlements and the needs of identified target groups, notably the ultra-low, low and middle income groups. "We are doing everything possible to have the remaining 572 commenced. These consist of 186 houses here at Swakopmund, 362 units at Otjomuise Extension 10 in Windhoek and 24 units at Opuwo". # CONSTRUCTION WORST HIT AS COMPANY INSOLVENCIES RISE AGAIN IN JUNE

The number of registered company insolvencies in England and Wales in June 2024 was 2,361, 16% higher than in May 2024 and 17% higher than the same month in June 2023.

The number of company insolvencies remained much higher than those seen both during and in the five years before the Covid-19 pandemic.

### **Construction Insolvencies**

Construction is the worst hit sector, registering the most insolvencies of any UK industry. It had almost one in five of all companies going out of business, with 17.3% of the total.

In the construction industry there were 4,287 company insolvencies in the 2023 to June 2024. Businesses involved in specialist construction accounted for most insolvencies with 211 going out of business in May 2024 – the month with the latest breakdown of figures.

Specialist firms include those carrying out demolition and site preparation, building finishing, including trades and installers and other specialist activities.

Meanwhile, firms involved in the development of building projects and the construction of residential and non-residential buildings saw 126 insolvencies in May 2024.

One in 179 companies on the Companies House effective register (at a rate of 55.8 per 10,000 companies) entered insolvency between 1 July 2023 and 30 June 2024.

This was an increase from the 55.1 per 10,000 companies that entered insolvency in the 12 months ending 30 June 2023. Company insolvencies in 2023 and the first half of 2024 are at levels last seen during the 2008-09 recession.

# U.S. CONSTRUCTION INDUSTRY SHOWS STABILITY AND STRENGTH IN 2024

The U.S. construction industry has shown resilience despite global challenges and the industry is adjusting to new patterns of demand, indicating variations in growth. JLL's new 2024 midyear construction update and reforecast details how the year has unfolded so far compared to original predictions and re-forecasts what is expected in the second half of 2024.

Construction costs have stabilized in 2024 due to backlog-conscious contractors and improved material conditions. Though construction starts remain slow in some locations, and not all sectors are performing equally well, construction spending is up, and some interest rate holdouts are moving on long-deferred projects.

"The construction industry in the U.S. is incredibly nuanced, and major changes to the built environment are happening now, driven by shifting economic and industry dynamics", said Julie Hyson, Americas Portfolio Clients, Services and Industries Lead, Project and Development Services, JLL. "Spending is up more than originally anticipated interest in projects has increased".

Regarding interest rates, "higher for longer" is still the working paradigm, even with some rate cuts on the horizon; the era of near-zero interest rates is not likely to return. Private sector construction spending is increasing, aided by some loosening of capital, and public spending has also provided market stability. Infrastructure investment and post-pandemic economic recovery will continue to support the construction industry for years to come, both directly and indirectly.

# **INCREASED COMPETITION, CHALLENGES FACING SOUTH AFRICAN CEMENT SECTOR**

Cement producer Sephaku Cement notes that, over the last 20 years the cement industry has evolved and fragmented, which has, in part, resulted in challenges related to ineffective enforcement of regulation and excess capacity in South Africa (SA).

The company explains that the cement industry has evolved from four integrated producers to six integrated producers, 11 cement blenders and five or six importers.

Sephaku chief executive officer, Duan Claassen notes that, in total, between all entities involved in the selling and distribution of cement in South Africa, there are over 80 different types of cement and/or brands on the market.

"While in its own right, this increased fragmentation is a challenge, one could argue that is has created a more competitive environment, which ultimately should benefit the consumer", elaborates Claassen.

However, he adds that the increased fragmentation brings the first existential threat to the industry, being the ineffective enforcement of regulations and quality standards.

South African cement standards — which mirror the European standards — are well structured. However, Claassen points out that there are some market participants that violate the regulations by producing cement products that fall significantly below the minimum standard. "These cements proliferate particularly in lower income areas, where the pressure on the purse is at its highest." He adds that a lack of consumer knowledge on this topic can significantly increase the risk of failures, leading to serious incidents.
