# Class A First Aid Course Code: FIA01 Based on demand | Windhoek

#### Overview

The course is aimed at teaching lay participants basic first aid skills and techniques through practical demonstrasions and exercises. Topics include Principles of First Aid, CPR, breathing difficulties and choking, bleeding and wound care, shock, unconsciousness, fractures, burns, head and spinal injuries, medical emergencies, allergies and other relevant topics and are prescribed by the Health and Safety Regulations.

### **Svllabus**

Basic principles of First Aid, Medico-Legal aspects of First Aid, Responsibilities of the First Aid attendant, knowledge of the ambulance system, reporting to higher level trained professionals, basic anatomy and physiology, patient assessment: primary / secondary survey, assessment and monitoring of basic vital signs, respiratory emergencies, management of airways, chest injuries, drowning, choking, cardio pulmonary resuscitation (CPR), circulatory emergencies: unconsciousness, fainting, stroke, bleeding & wounds, shock, abdominal injuries, fractures, head injuries, spinal injuries, pelvic injuries, epilepsy, diabetes, burns, poisoning, drugs & substance abuse, problems of health & cold, emotional problems, snake bites, scorpion stings and others, Occupational health & safety regulations, contents of first aid box.

### Conditions
